

### LIFETIME FRAME AND SASH

EnergyWall Windows & Doors warrants that the vinyl extrusions manufactured from EnergyWall Vinyl Compound, for use by EnergyWall Windows & Doors in fabricating the windows and patio doors, are free from defects in material and workmanship in the course of manufacture and will not materially rot, rust, crack, warp, pit, corrode, peel or blister during the warranty period and will not materially fail to maintain their basic color characteristics in the warranty period

#### **INSULATED GLASS LIMITED WARRANTY**

EnergyWall Windows and Doors warrants that its insulating glass units (the Product) will be free from material obstruction of vision as a result of dust or film formation on the internal glass surfaces caused by failure of the hermetic seal due to faulty manufacturing of the unit. The EnergyWall Windows and Doors warranty of the Product shall extend for a period of thirty (30) years after the date of installation. Should the glass fail after the year indicated below as a result of defects, then EnergyWall Windows and Doors will charge you a fixed percentage of the company's selling price for insulated glass at that time, according to the following schedule.
